NEW ASX AND SFE MARKET RULES – EDUCATION AND CONSULTATION

ASX has released for exposure the proposed new ASX and SFE Market Rules to be effective post-transition of certain supervisory responsibilities to ASIC.

ASX will be conducting education and consultation seminars on the proposed new rules in Brisbane, Sydney, Adelaide, Perth and Melbourne in April 2010.
